Range Rules – Mount Airy Straight Shooters (MASS) Program (subject to change)

1. All MAC IWLA [range rules](#) apply, including RSO badging requirements and **signing in AND out in log book**. What follows is in addition to those rules when operating under the MASS program. MAC IWLA waiver, USA Archery waiver, and program registration forms, and payment are required from all participants by deadline provided.
2. **(INSTRUCTORS)** –
 - a. When **setting up for ranges** for shooting:
 - i. a clearance area shall be marked off (e.g., with stakes and flagger tape) to delineate danger areas while shooting
 - ii. an embankment or ballistic curtain must be behind targets to catch stray arrows
 - iii. a flag or cone must be placed on firing line to indicate when someone is down range
 - b. For any **classes given that include students under the age of 18:**
 - i. a copy of the instructor’s USA Archery certification and Range Pass (as applicable indicating “Safe Sport” training and background screening), is required to be provided to the Program Administrator for verification and filing
 - ii. a parent or guardian must be present during the entire event (or as in the case in Girl Scouting, responsible adults with permission slips, the proper adult to child ratio, and first aider – verification of the group’s policy must be provided in writing before the event – e.g., “*Girl Scouting’s Safety Activity Checkpoints*” policy)
 - c. USA Archery [Range Rules Poster](#) shall be posted during all classes and events. (see example on right)
3. **NEVER:**
 - a. dry fire a bow (without arrow)
 - b. point or shoot at anything except the target
 - c. use broad heads (non-field points)
 - d. use non-club equipment without inspection by instructor first, and NEVER a draw weight over 40# with MASS targets (or 30# with single ballistic curtain in place)
 - e. attempt to repair club equipment, *but do label the equipment with what the problem is and how it happened so it may be addressed before the next use*
4. **ALWAYS:**
 - a. follow instructions
 - b. respect instructors and other students
 - c. respect the equipment
 - d. shoot from same firing line (instructors may move target closer to firing line to shorten distance)
 - e. consider additional safety rules from participating groups (e.g., see Girl/Boy Scouting rules that follow)
 - f. dress appropriately (e.g., closed toe shoes, avoiding loose clothing/jewelry that can get caught in a bow or string)
5. **VIOLATION** of any rule under the MASS program may result in expulsion without refund, at the discretion of the instructor or administrator.
